- | **Chairs** for club equipment store. 2 Chairs have been bought & are in club garage
- | **Badge Events** schedule:

- | **Short Races/Badge Blidworth weekend 3rd/4th Feb 2001** The following weekend 10th/11th Feb 2001 is to be a Future Champs Short races & National Race combined weekend (National in the W Midlands). There had been a request from HP whether NOC might host the short races on 10th Feb 2001. Discussed the implications for nos. attending our events. Decision to go ahead with our planned double weekend & not offer to host short races the following weekend.
- | **Organising Events** - options for change discussed in the light of difficulty in finding organisers - aim to simplify the job of the organiser New structure of helper groups agreed - to be task orientated Reply slip in next Black & Green - members to volunteer for a task e.g. start, finish, registration etc. & return reply slip to HO. If no reply received task will be allocated. Agreed that members may wish to transfer to another helper group & may apply to do so after a stint in one group. Potential team leaders to be approached & marked on the helper list. The organiser to approach the team leader & team leader to approach helper members, thus making the task of the organiser easier.
- | **Financial**
 - Sherwood Pines net loss £200.22 (incl deduction mapping costs)
 - Little John Relays profit £127.45
- | **Helpers Entry Fees** - under new levy system we have to pay the levy even for 'free' runs for helpers which now therefore causes the club a loss. Agreed helpers to pay half price in order to cover the levy i.e.£1.50 for adults & 50p Juniors - to put note in B&G to explain
- | BOF organised **club coaching day** is being arranged for 21st/ 22nd Oct 2000 (venue High Dam - controls,maps, access organised by BOF). Being considered for a NOC coaching weekend.
- | EMOA **ePunching** Sub committee - recommended Sport Ident. System to be purchased Substantial contributions will be needed from clubs EMOA. Bob Alderson in process of developing proposals for funding
- | **EMOA AGM** date 11th Sept 2000
- | **British Champs Ireland 2001** - EM Committee considered but decided impractical to organise transport to Ireland for this. NOC to consider whether club-organised transport practical- CH to cost & then canvass views in B&G
- | EM turn to put on finals of **Junior Club Competition** (10/12/2000) NOC event on 10/12/2000 appropriate- to volunteer this event
- | **Regional Coaching Course** - 2nd/3rd Sept 2000 apply via BOF
- | **N Notts Coalfield area** - announcement expected that this will be a Sport Action Zone To consider any ways we might tap into this source of funding (still to be announced)
- | **British Champs Women's Premier Relay** race voided CH has lodged a protest on behalf of NOC
- | **Code of Ethical Conduct** proposed (based on DVO document) Produce such a document & propose to NOC AGM to incorporate into NOC constitution
- | **Control kites** - many confusing because of multiple Nos. Planners to throw away those in

poor condition- there is a store of new kites in the garage

- | **Trestles/Canes** - child injured by a cane tip at Jan Short Races 2000 Decided to use trestle punches until E punching likely to be purchased for 2001
- | **BOF Restructuring** - BOF AGM agreed to go ahead with process of considering moves to 4 Nation structure
- | **Mappers** who are paid might need to declare earnings to Inland Revenue
