- | **E Punching - lottery funding agreed**, next E punching sub committee meeting 23rd October to discuss remainder of funding from EMOA/Clubs SW unable to attend next meeting, agreed TD will go to represent NOC
- | **E Punching training** - Mike Napier & EMOA 2 or 3 NOC members to attend for training in use of E punching technology - agreed to advertise in B&G for volunteers
